The Honorable Stephen Hill moved to endorse Chair Fowler’s action in allowing SB 123 treatment providers to bill for telehealth services effective March 17, 2020. Pat Colloton seconded the motion. The motion carried.

**LS/CMI and WRNA Trailer Tool**

Jessica Domme moved to amend the implementation date of the Level of Service/Case Management Inventory assessment tool (LS/CMI) to July 1, 2021 and the implementation date of the Women’s Risk Needs Assessment (WRNA) trailer tool to January 1, 2021. Amy Raymond seconded the motion. The motion carried.
